Call for Papers

The Centre for Rising Powers stems from the burgeoning interest in scholarly and policy circles in the emergence of new powers, the so-called BRICs (Brazil, Russia, India, and China). It is the first initiative of its kind however that goes beyond the attention to the immediate cases to focus on the fundamental theoretical and empirical puzzle: how do new powers rise, how might they be accommodated, and what impact do these interactions generate on systemic stability. Its research programme is thus just as interested in the threats and opportunities posed by the rise of new powers in the past (such as Germany, Japan, the United States and the former Soviet Union in the 20th century) as the emergence of new powers today (such as India, China, and Brazil).

Our research agenda is wide-ranging in its selection of case studies, and thrives on interdisciplinary exchange between Politics, History, and Economics. We have close and deepening links with universities, think tanks, policy institutions, and private sector actors in the new powers. Our research spans the negotiation behaviour of new powers across institutions, issue-areas, and regimes: climate change, energy, trade, financial and monetary affairs, migration, poverty reduction, sustainable development, and different aspects of security studies. The Centre's aim is to serve as the hub of cutting-edge international and interdisciplinary research on the subject of past, present, and future rising powers.

Our commitment to excellence is not restricted to the ivory towers of intellectual enquiry, but has direct policy relevance. Power transitions are one of the key sources of deadlock and conflict, but they also have the potential to act as sources of renewal and change for the better. The study of rising powers fostered by the new Centre aims to directly impact the preservation of international cooperation, peace and stability, and also the promotion of values of efficiency, fairness, and justice in the global order.

Call for papers: The CRP working paper series is published quarterly, and offers a venue for the publication of pioneering research within the broad field of 'Rising Powers.' We invite scholars, policymakers and practitioners to submit their research for this series. All submissions will be subject to a peer-review process.

Online publication: Papers accepted as part of the CRP Working Paper Series will be published on the CRP's website and disseminated electronically to the CRP's network of interested organisations and persons. There is no monetary compensation offered to Working Paper Series authors. Authors are welcome to re-publish papers used in this series elsewhere, so long as reference is made to their prior publication in the CRP Working Paper Series.

Guidelines: Papers should be between 6,000 and 8,000 words in length. They must be written in British English and submitted in Microsoft Word format.
