



CRP WORKING PAPER SERIES Guidelines for Contributors

Scope

The CRP working paper series is a peer-reviewed working paper series. The CRP research agenda is wide-ranging in its selection of case studies, and thrives on interdisciplinary exchange between Politics, History, and Economics. We have close and deepening links with universities, think tanks, policy institutions, and private sector actors in the new powers. Our research spans the negotiation behaviour of new powers across institutions, issue-areas, and regimes: climate change, energy, trade, financial and monetary affairs, migration, poverty reduction, sustainable development, and different aspects of security studies.

The Centre's aim is to serve as the hub of cutting-edge international and interdisciplinary research on the subject of past, present, and future rising powers. Our research agenda is thus just as interested in the threats and opportunities posed by the rise of new powers in the past (such as Germany, Japan, the United States and the former Soviet Union in the 20th century) as the emergence of new powers today (such as India, China, and Brazil).

We welcome working papers which contribute to our research agenda.

Submissions

Originality

The CRP working paper series welcomes works that are not already published elsewhere. However, we welcome working papers which aim or is expected to be published in a peer reviewed journal (or book chapter). Authors are encouraged to incorporate the comments from the editorial board and readers and submit to publication elsewhere, so long as reference is made to their prior publication in the CRP Working Paper Series.

Length and format

Papers should be between 6,000 and 8,000 words in length. This includes footnotes and bibliography. Please provide a word count in the document. Papers must be written in English and submitted in Microsoft Word Format (both .doc and .docx formats are acceptable). Accepted papers will be converted into PDF format for online publication.

Manuscript

- Include consecutive page numbers at the bottom centre of the text.
- Use Garamond font, size 12 for the main text.
- The paper size should be A4. Please double space the text.
- Please include a brief abstract, no more than 500 words in length.

The CRP Working Paper Series uses footnotes instead of endnotes. Please use numbered footnotes for in-text citations instead of parenthetical referencing:
